1.2. Intended Use of the Product

A complex combination of hydrocarbons separated and/or condensed from natural gas and containing carbon numbers predominantly in the range C₂ - C₂₀. Can contain as much as 15 - 20 wt% methane (C₁), ethane (C₂), and propane (C₃), 20 wt% butanes (C₄) and up to 6 - 7 % carbon dioxide (CO₂) depending on natural gas production process conditions and pressure.

2.3. Other Hazards

Exposure may aggravate pre-existing eye, skin, or respiratory conditions. Contains benzene, a regulated human carcinogen. Benzene has the potential to cause anemia and other blood diseases, including leukemia, after repeated and prolonged exposure. Exposure to light hydrocarbons in the same boiling range as this product has been associated in animal studies with systemic toxicity. See also Section 11 – Toxicological Information. Contains trace amounts of hydrogen sulfide that can accumulate into dangerous concentrations. Hydrogen sulfide is a fatal, and highly flammable gas with a rotten egg odor that quickly causes odor fatigue. Heating of this product and storage under elevated temperatures or over long periods of time may release higher amounts of hydrogen sulfide. Hydrogen sulfide is also an asphyxiant.

SECTION 4: FIRST AID MEASURES

4.1. Description of First-aid Measures

Inhalation: High concentrations may cause central nervous system depression such as dizziness, vomiting, numbness, drowsiness, headache, and similar narcotic symptoms.

WARNING: The burning of any hydrocarbon as a fuel in an area without adequate ventilation may result in hazardous levels of combustion products, including carbon monoxide, and inadequate oxygen levels, which may cause unconsciousness, suffocation, and death.

WARNING: irritating and toxic hydrogen sulfide gas may be present. Greater than 15-20 ppm continuous exposure can cause mucous membrane and respiratory tract irritation. 50-500 ppm can cause headache, nausea, and dizziness. Continued exposure at these levels can lead to loss of reasoning and balance, difficulty in breathing, fluid in the lungs, and possible loss of consciousness. Greater than 500 ppm can cause rapid unconsciousness and death if not promptly revived.

Skin Contact: Redness, pain, swelling, itching, burning, dryness, and dermatitis.

Eye Contact: May cause slight irritation to eyes.

Ingestion: The major health threat of ingestion occurs from the danger of aspiration (breathing) of liquid drops into the lungs, particularly from vomiting. Aspiration may result in chemical pneumonia (fluid in the lungs), severe lung damage, respiratory failure and even death.

Chronic Symptoms: May cause genetic defects. May cause cancer. Suspected of damaging fertility or the unborn child. Causes damage to organs (liver, kidneys, blood, nervous system, skin) through prolonged or repeated exposure.

4.3. Indication of Any Immediate Medical Attention and Special Treatment Needed

If exposed or concerned, get medical advice and attention. If medical advice is needed, have product container or label at hand.

SECTION 5: FIRE-FIGHTING MEASURES

5.1. Extinguishing Media

Suitable Extinguishing Media: Dry chemical powder, alcohol-resistant foam, carbon dioxide (CO₂). Water may be ineffective but water should be used to keep fire-exposed container cool.

Unsuitable Extinguishing Media: Do not use a heavy water stream. A heavy water stream may spread burning liquid.

5.2. Special Hazards Arising From the Substance or Mixture

Fire Hazard: Highly flammable liquid and vapor. Vapors may be ignited rapidly when exposed to heat, spark, open flame or other source of ignition. Flowing product may be ignited by self-generated static electricity. When mixed with air and exposed to an ignition source, flammable vapors can burn in the open or explode in confined spaces. Being heavier than air, vapors may travel long distances to an ignition source and flash back. Runoff to sewer may cause fire or explosion hazard.

Explosion Hazard: May form flammable or explosive vapor-air mixture. When mixed with air and exposed to an ignition source, flammable vapors can burn in the open or explode in confined spaces. Being heavier than air, vapors may travel long distances to an ignition source and flash back. Runoff to sewer may cause fire or explosion hazard.

Reactivity: Reacts violently with strong oxidizers. Increased risk of fire or explosion.

5.3. Advice for Firefighters

Precautionary Measures Fire: Exercise caution when fighting any chemical fire.

Firefighting Instructions: Use water spray or fog for cooling exposed containers. In case of major fire and large quantities: Evacuate area. Fight fire remotely due to the risk of explosion. Small fires in the incipient stage may typically be extinguished using handheld portable fire extinguishers and other firefighting equipment. Firefighting activities that may result in potential exposure to high heat, smoke, or toxic by-products of combustion should require NIOSH/MSHA- approved pressure-demand self-contained breathing apparatus with full face piece and full protective clothing. Isolate area around container involved in fire. Cool tanks, shells, and containers exposed to fire and excessive heat with water. For massive fires the use of unmanned hose holders or monitor nozzles may be advantageous to further minimize personnel exposure. Major fires may require withdrawal, allowing the tank to burn. Large storage tank fires typically require specially trained personnel and equipment to extinguish fire, often including the need for properly applied firefighting foam.

Protection During Firefighting: Do not enter fire area without proper protective equipment, including respiratory protection.

Hazardous Combustion Products: Carbon dioxide, carbon monoxide, smoke, fumes, unburned hydrocarbons and oxides of sulfur and/or nitrogen. Hydrogen sulfide and other sulfur-containing gases can evolve from this product particularly at elevated temperatures.

Other Information: Do not allow run-off from fire fighting to enter drains or water courses.

SECTION 6: ACCIDENTAL RELEASE MEASURES

6.1. Personal Precautions, Protective Equipment and Emergency Procedures

General Measures: Do not get in eyes, on skin, or on clothing. Keep away from heat, hot surfaces, sparks, open flames, and other ignition sources. No smoking. Use special care to avoid static electric charges. Do not breathe vapor, mist or spray. Do not handle until all safety precautions have been read and understood.

6.1.1. For Non-Emergency Personnel

Protective Equipment: Use appropriate personal protective equipment (PPE).

Emergency Procedures: Evacuate unnecessary personnel. Stop leak if safe to do so.

6.1.2. For Emergency Personnel

Protective Equipment: Equip cleanup crew with proper protection.

Emergency Procedures: Upon arrival at the scene, a first responder is expected to recognize the presence of dangerous goods, protect oneself and the public, secure the area, and call for the assistance of trained personnel as soon as conditions permit. Ventilate area. Eliminate ignition sources. Product may release substantial amounts of flammable vapors and gases (e.g. methane, ethane, propane), at or below ambient temperature depending on source and process conditions and pressure.

6.2. Environmental Precautions

Prevent entry to sewers and public waters. Avoid release to the environment. Collect spillage.

6.3. Methods and Materials for Containment and Cleaning Up

For Containment: Contain any spills with dikes or absorbents to prevent migration and entry into sewers or streams. As an immediate precautionary measure, isolate spill or leak area in all directions.

Methods for Cleaning Up: Evacuate nonessential personnel and remove or secure all ignition sources. Consider wind direction; stay upwind and uphill, if possible. Evaluate the direction of product travel, diking, sewers, etc. to confirm spill areas. Spills may infiltrate subsurface soil and groundwater; professional assistance may be necessary to determine the extent of subsurface impact.

Carefully contain and stop the source of the spill, if safe to do so. Protect bodies of water by diking, absorbents, or absorbent boom, if possible. Do not flush down sewer or drainage systems, unless system is designed and permitted to handle such material. The use of firefighting foam may be useful in certain situations to reduce vapors. The proper use of water spray may effectively disperse product vapors or the liquid itself, preventing contact with ignition sources or areas/equipment that require protection.

Take up with sand or other oil absorbing materials. Carefully shovel, scoop or sweep up into a waste container for reclamation or disposal – caution, flammable vapors may accumulate in closed containers.

Response and clean-up crews must be properly trained and must utilize proper protective equipment (see Section 8).

SECTION 7: HANDLING AND STORAGE

7.1. Precautions for Safe Handling

Additional Hazards When Processed: Handle empty containers with care because residual vapors are flammable. If stored under heat for extended periods or significantly agitated, this material might evolve or release hydrogen sulfide, a flammable gas, which can raise and widen this material's actual flammability limits and significantly lower its auto-ignition temperature. Hydrogen sulfide is a toxic gas that can be fatal. It also has a rotten egg smell that causes odor fatigue very quickly and should not be used as an indicator for the presence of gas.

Naturally Occurring Radioactive Material (NORM): Industry experience indicates this material may contain small amounts of naturally-occurring uranium, thorium, and their decay products (NORM) which can accumulate in oil production and process equipment, particularly the equipment handling the water associated with production.

Production equipment should be assessed for external gamma radiation and access may need to be restricted in accordance with OSHA 29 CFR 1910.1096 during operation.

Production equipment should also be assumed to be internally contaminated with long half-life decay products that emit alpha radiation, which is a hazard if inhaled or ingested. Unless measurements indicate otherwise, steps should be taken to minimize skin and inhalation risk exposure to NORM dusts/mists by wearing personal protective clothing, utilizing respiratory protection, and practicing good personal hygiene. Please refer to API Bulletin E2, "Bulletin on Management of Naturally Occurring Radioactive Materials in Oil and Gas Production" for additional information on managing NORM.

Scales, sludge and other deposits from this equipment may have an accumulation of NORM.

Precautions for Safe Handling: Wash hands and other exposed areas with mild soap and water before eating, drinking or smoking and when leaving work. Take precautionary measures against static discharge. Use only non-sparking tools. Avoid contact with eyes, skin and clothing.

Hygiene Measures: Handle in accordance with good industrial hygiene and safety procedures.

7.2. Conditions for Safe Storage, Including Any Incompatibilities

Technical Measures: Comply with applicable regulations. Take action to prevent static discharges. Ground and bond container and receiving equipment. Use explosion-proof electrical, ventilating, and lighting equipment.

Storage Conditions: Store in a dry, cool place. Keep/Store away from direct sunlight, extremely high or low temperatures and incompatible materials. Store in a well-ventilated place. Keep container tightly closed. Keep in fireproof place.

Incompatible Materials: Strong acids, strong bases, strong oxidizers.

Storage Area: Hydrogen sulfide vapors may be evolved from long-term heated storage and/or agitated transport. Hydrogen sulfide is corrosive to most metals. It can cause steel pipe to become blistered, pitted, and brittle. Metal components used for storage should be resistant to sulfide stress cracking. (See appropriate API and NACE standards.)

7.3. Specific End Use(s)
